As you all know, our (5103) Contract as well as the National Addendum expires on September 30th. We finally have dates to bargain! (took them long enough). We will be bargaining in Washington on August 28, 29 and 30th. Locally we will be at the table (location yet to be determined) on September 10th, 11th and 13th. We will be training our bargaining team very soon. It is not our choice to open our Local Contract, so we are looking simply to maintain our current language. We have no intention of giving anything up, or giving anything back either nationally or locally!! Some of the Coalition locals throughout the country have begun bargaining, and we are watching that closely. As of the end of last week, there were no substantive tentative agreements in any of our locations, and bargaining was contentious (or worse) in some places. Please continue to wear your HPAE pins, and YES, YOU ARE ALLOWED TO WEAR THEM ON YOUR SCRUBS!! The Letter of Agreement on page 41 of our local contract allows pins that show only the name of the union and it's logo.

You must remove them if a SPONSOR asks that you do. Notice that a supervisor is NOT a sponsor.


