PRESIDENT'S MESSAGE

Temple University Hospital Episcopal Campus has become Ground Zero for treating patients of the opioid crisis. With the mayor's initiative to clean up the drug the open-air drug market along Kensington and Allegheny avenues has subsequently pushed addicts to adjacent neighborhoods but not solving the underlying issue. In recent months Episcopal Campus has been inundated with an increase in overdoses being brought to the Emergency Department for treatment. With these patients there has been an increase in violent episodes and violent assaults perpetrated against our union members. Drugs and weapons are consistently eluding the current security check point in the emergency department these incidents go unreported. It is your duty to file a Midas so the employer can be served notice. Statistically healthcare workers are 5 times more likely to be assaulted on the job than any other profession. We have stressed will continue to stress to management the importance and necessity of providing a safe work environment for our membership, patients, and visitors by implementing better safety measures.
