Said nomination forms must be submitted no later than the timeline set forth in the Notice of Election. A member may not nominate more than one candidate for the same position. NOMINATIONS DEADLINE:	Must be received by 1:00 p.m. on January 9, 2025
ELECTION INFORMATI	<b>ON:</b> Ballots to be mailed to all members in January. If it is an uncontested election, the committee will cast one ballot on behalf of the slate in which case no ballots will be sent. All candidates may examine membership list and be present for the mailing and counting of the ballots. You must advise the committee in writing if you wish to be present or would like to view membership list. The reason for this is they will then share all the necessary information such as place and time. Candidates must abide by "rules of conduct" establish by committee. If any candidate does not receive the rules of conduct, please contact a committee member.
ELIGIBILITY:	Any HPAE Local 5107 member in good standing as of June 1, 2024 are eligible to run for office. All elected candidates must adhere to the good standing requirement s through term of office and meet all qualification under Constitution and By-laws of Local 5107. New Officers must attend HPAE Officer training.
